

A further thanks must go to Dr Regan Neumann, Kym Turner and Julissa Vasquez from the State Schools Rural, Remote and International team at the Department of Education for facilitating the meetings with all the relevant departments. Following conference all the motions are collated and sent to the rural and remote team who then forward the issues to the relevant areas for consideration. As a result, State Council has been able to meet with the right people to discuss the issues across all our portfolios and in many instances, issues have been resolved quickly. Of course, we continue to have motions on the books that are ongoing issues. Surely the squeaky wheel approach will yield success one day.

Following our October conference, we updated our Position Statement Flyer with our Key Issues for 2020/21. Our key issues are prioritising Geographically Isolated Students at Distance Education Schools, Reinstatement of the Schools Touring Program, Financial Assistance and Attraction and retention of quality teachers in rural and remote areas. We have emailed this document far and wide including all parliamentarians and key stakeholders.

Whilst there has not been an opportunity for a formal parliamentary delegation in this short council year we did squeeze a few meetings with members of the house whilst in Brisbane for delegations. Most notably Dr Christian Rowan, Shadow Minister for Education, and James Lister, member for Southern Downs, who tabled our key issues.

Delegations proved to be reasonably fruitful. We had the opportunity to discuss our key issues with the Minister for Education, Grace Grace, and the Assistant Director of Education, Peter Cook. State Council has been assured that the overcrowding of DE classrooms will be addressed, and a review of the Schools of Distance Education is underway. Our meeting with the IT department had positive outcomes as they confirmed to State Council that the increased bandwidth provided to the DE schools during Covid will continue and be the new norm. The IT branch also announced \$400 million over 5 years to upgrade connectivity to Queensland State Schools. This will leave only a very small number of remote schools left on Satellite and even they will get an upgrade to a business service rather than Skymuster.

### ISOLATED CHILDREN'S PARENTS' ASSOCIATION QUEENSLAND Inc

ICPA's relationship with the department continues to reflect the high value they place on our organisation – we are represented on many stakeholder groups including the Joint Parent Council, the Rural and Remote Education Reference Group,



Early Years Forum and the Senior Assessment and Tertiary Entrance Implementation Taskforce to name a few. I also sit on the Telstra Regional Advisory Council and more recently the newly formed Agforce Social Policy group. Thanks must also go to the other parent groups with whom we work closely – P&Cs Qld, Catholic School Parents Queensland, and Queensland Independent Schools Parent Network.

Queensland Council continues to have joint meetings with Federal council and the other states. Our zoom meetings over the past year have been invaluable, with each council offering support to each other and the sharing of ideas. Kelly Ostwald and I have attended two of these meetings this year so far. We remain hopeful that we will be able to gather as a group in person for a weekend meeting in the not too distant future.

Thank you to all our sponsors, many of whom support ICPA year after year. ICPA is immensely proud of the fact that we have never needed to source government funding or grants to survive and for this we are incredibly grateful. This enables us to remain apolitical and not beholden to any other organisation in our advocacy.

Thank you to branches and delegates who have put motions on the Conference Agenda. Some are new, and some have been put forward for many years. We continue to highlight the inequities faced for rural and remote students including, in home care, access to specific needs, lack of options for students at rural and remote high schools, the inability to access easily quality vocational education programs and many other issues. Even though we may not have some of these longstanding lobbies over the line, you can rest assured we are working away in the background on all our policy issues.

Thank you to our councillor team. There have been some hard yards done to make it here today in one piece following a very hectic 7 months. Not only have we been advocating on behalf of all the members through delegations and stakeholder meetings, but there have also been several other significant activities that we have been attending to. We have submitted a grant to the Regional Arts Fund to raise funds to produce a Golden Jubilee book, celebrating 50 years of ICPA. We have attended Beef week promoting ICPA and selling close to \$5,000 worth of personalised Cattle Tags, which is also earmarked for the book, no pun intended!. Thank you to Allflex and Nutrien for the opportunity. Thanks to Councillors Amanda Clark and Rob McArthur, for pulling this together and all the Qld ICPA branch members who volunteered.

There has also been the massive undertaking of building the new website and transferring all our data from the old site to the new one. Melissa Iland and Tammie Irons have gone way over their usual time remit in making our new Qld page look amazing. In fact, Tammie has enjoyed it so much she has officially become our WebTech Officer!!

Pulling together the 50-year conference has been an extra job we have all taken on, but with relish as we have enjoyed so much reminiscing on times past and appreciating how easy we have it now!! For this commemorative milestone event we have printed you all a copy of the motion booklets as a memento on the occasion. A big thanks to Jacqui Beale (Mitchell/Tomoo/Dunkeld Branch), and past councillor who has gathered items from near and far for the memorabilia display. Thanks also to Di Selby, Moonie Branch for all her efforts to locate and contact so many past councillors and coordinating the past councillors get together. We are thrilled to have so many of you and I encourage current members to have a chat with you all and tap into the wealth of ICPA knowledge that you have.

I am pleased to be presenting the Treasurer's report and audited financial statements for the 2020 – 2021 financial year.

Auditing of ICPA Qld Inc financials has been conducted by Ringrose Button chartered accountants and are attached to the AGM report. ICPA QLD Inc has run at a cash profit this year of \$8,431.31 and remains in a very stable position with \$101,462.19 invested in a term deposit.

Total funds available as of 31<sup>st</sup> March 2021 were

\$221,914.67. The profit and loss statement outlines a snapshot of the income and expenditure for the 2021 financial year.

A total income of \$141,605.32 was received – donations & sponsorship being the major income at \$72,634.48, with \$9,700.00 from ICPA branches and a substantial donation from the Roma convening committee from the 2020 Online State Conference of \$31,174.26. Thank you to the Roma convening committee and the following ICPA branches for assisting State Council with donations – Alpha, Blackall, Charters Towers, Clermont, Julia Creek, Kindon and Richmond.

region and the Pilbra branch in Western Australia donated money to assist with membership fees for North Western Qld branches affected by the 2019 floods. This year ICPA Qld has partnered with Outback Insurance to provide ICPA Branches with a donation when ICPA members renew or take out a new insurance policy with Outback Insurance. This offer has provided many ICPA branches with donations. Sincere thanks to all organisations and branches who have supported ICPA Qld this year.

Other major income included fundraising with Art Union ticket sales at \$19,364.00 and Bush Christmas ticket sales at \$10,412.60. Branch membership state affiliation fees of \$25,346.00 were received. The remaining income received came from Friends of ICPA Qld and News & Views subscriptions, News & Views advertising, Federal Corporate memberships and interest.

The large contribution to ICPA Qld's income each year is Fundraising. As previously mentioned sales of the ICPA Art Union tickets, ticket sales at Bush Christmas and the sale of souvenirs contributes to Fundraising income throughout the year. Thank-you to all sponsors and supporters of the ICPA Art Union and Bush Christmas. Thank-you to Margie Greenway and everyone who assists with Bush Christmas ticket sales. The introduction to online tickets sales this year for the ICPA Art Union has been successful and an easy option to sell and collate art union ticket sales. The time and effort our Fundraising Officer, Annie McGill has put into fundraising this year has been very much appreciated. Thank you.



Each year a significant amount of funds are required for ICPA Qld State Council to

continue lobbying Government departments to achieve a better educational outcome for our members' children. This lobbying has costs associated to assist State Councillors to travel considerable distances from home to attend these meetings. Total expenses for the year came to \$133,174.01 with \$56,773.38 covering State Council expenses. State Council expenses include accommodation, flights, travel and other related expenses for councillors to attend delegations, state and federal conferences, mid-year meetings, along with other relevant meetings and conferences. Other major expenses include \$24,171.68 for News & Views publication & postage, \$10,296.64 for insurance and \$7,491.76 for fundraising expenses.

### **Membership**

The 2020 membership year closed with a total of 1,135 members and at the close of the financial year, 31st March 2021, there was 1,106 members. Memberships for the 2020 year were down slightly in comparison to the previous year. As always, memberships continue to flow in throughout the year and online membership renewal has continued to have a great uptake this year. Online is the preferred method for paying membership and it is great to see those branches encouraging the use of online membership for renewals or new memberships. At the time of writing this report, the membership database was slowly being updated due to the new website under construction. The process of paying Qld memberships is being reviewed by the membership officer and treasurer so the process will be easier for branch treasurers. Once updated all branch treasurers will be informed of the new process. Thank- you to Louise Winten, Qld Membership Officer & Jane O'Brien, Federal Membership Officer for all the hard work and many hours you put into keeping all our memberships records in order. Our membership base is what makes ICPA a strong organisation, so we encourage all branches to continue to engage and advocate for new and existing members to become involved in any way possible to support ICPA.

Just a reminder to branch executives, that if submitting your memberships manually, it would be fantastic if you could have them submitted prior to the 1st March each year. This ensures your members remain on both the State and Federal mailing databases. If your branch has Branch Life members, both State and Federal fees for these members are the responsibility of the branch and must be paid each year. All members need to keep their postal and email addresses up to date and notify State Council when changes occur. This makes the delivery of information and publications to members much more effective.

Friends of ICPA Qld have continued to grow in the 2020 – 2021 financial year with 59 members from organisations across Queensland. As Friends of ICPA Qld, members received an invitation to the annual conference, editions of ICPA Qld News & Views and ICPA Australia Pedals and the Qld Compass email keeping them update with ICPA happenings.

### **Risk Management**

As State Treasurer, I am also the Risk Management Officer, so a reminder to all branches to send in completed risk management forms at least two weeks prior to branch events. If your branch has questions related to activities and insurance do not hesitate to contact me. It is important, that as members, you are covered, along with those attending your events.

Due to Covid restrictions, activities hosted by ICPA Branches were reduced over the 2020 – 2021 financial year. The following activities are reported from October to December 2020. Cunnamulla and Blackall held catering at a MLA information day and bull sale. ICPA children were supported with a smaller than usual variety of sports camps with Mitchell- Tomoo/Dunkeld holding a swag camp for a day, St George Breaker Camp and Tambo's Swim& Art Clinic. The beginning of 2021 has seen a small increase in branch activities when Alpha branch hosted the Alpha Cricket day, and the Charters Towers branch hosted the Charters Towers Swim



Clinic. It is pleasing to see branch activities growing and more activities being held by ICPA Branches across the state.

### News & Views

News & Views Editors, Lisa Southern and Jacque Hemming have done a remarkable job of compiling ICPA Qld's quarterly magazine for members. It is always enjoyable to receive the News & Views in the mail and to sit down with a coffee for an informative and interesting read. Thank you to Lisa and Jacque for coediting the News & Views magazine and continuing to source advertising to help keep the printing and distribution costs down.

As I near the end of my Treasurer's report thank-you to all State Councillors for assisting me in my role as Treasurer. A thank you to all branch executives for the tireless hours you volunteer to keep your branches ticking. I would like to thank the Cunnamulla convening committee for all the effort and time invested to host a successful 50<sup>th</sup> year conference. Finally, thank-you to all previous state councillors who have paved a pathway for ICPA Qld to continue lobbying for equality in education for our rural and remote children. Volunteers are just ordinary people with extraordinary hearts that reach out and together make a difference.

## THE EARLY YEARS



QLD STATE COUNCIL FORMATION IN CHARLEVILLE 2/11/1971

The Isolated Children's Parents Association Australia was formed in Bourke in April 1971.

Cunnamulla Branch may claim the fame of the very first Branch formed in Queensland on 28<sup>th</sup> August 1971 but it was Melbourne Cup Day, 2<sup>nd</sup> November, 1971 that a meeting was held at Corones Hotel in Charleville to form the first State Council of ICPA.

At this meeting were representatives of the first branches formed in Qld and the first executive were elected.

President – Mr Bunny Powne, Bollon Branch

Vice President – Mrs Gwen Vail, Blackall Branch

Secretary/Treasurer - Mr Tony Gall, Dirranbandi Branch

Committee – Mr John Parkinson, Blackall, Mr Malcolm Patterson, Langlo Crossing and Mr Alan Murray, Charleville

A few weeks after this meeting, on the 25<sup>th</sup> November, once again at Corones Hotel, the Charleville Branch was formed with Mr Alan Murray was elected President, Mr Tim Agar as Secretary/Treasurer and Mrs Leah Fisher as Assistant Secretary. Mr Murray and Mr Agar went on to become Qld State Councillors.

The story goes that there had been great rain and flooding creeks and parents were doing everything they could to get to this meeting, inspired and motivated to ensure high quality education of their children in Rural and Remote areas.

As with most branches distance, dirt roads, creek crossings, not to mention correspondence lessons made meetings difficult to organise however these early pioneering Branches did so without any of the technology we rely on today – it was even long before copy machines and faxes. We are very fortunate to have the original handwritten minutes of both the Qld State Council and Charleville Branch Inaugural Meetings in our archives.

Charleville Branch hosted the 25<sup>th</sup> Silver Jubilee Conference in 1996 and hosted the Registration Dinner at Corones Hotel in recognition of the Inaugural Meeting for form Qld State Council in 1971.

## WELCOME TO CUNNAMULLA



Good morning everyone.

Many of you have travelled a considerable distance to be with us today which is most appreciated. This Conference is a very significant event for the Cunnamulla branch. Although small in numbers, and spread over vast distances, each member has spent hours and hours in ensuring that this is the very best conference ever.

Why are we here??? It is to mark a very significant event that happened fifty years ago. It is very special for the Cunnamulla branch of ICPA. It was fifty years ago that Cunnamulla was the first ICPA branch to be formed in Queensland. This was on 28<sup>th</sup> August 1971, just four months after Bourke was formed. The meeting was organised by Cunnamulla identities, Lex Stephenson and Geoff Arthur. Geoff Arthur was a member of the foundation Federal Executive for three years. Lex Stephenson was elected as the first Branch President. Later his wife Beulah was elected as branch Secretary and Treasurer. They both retired in 1974. In 1981, they were both awarded Life Membership of the Branch for their outstanding commitment to ICPA. By 1975 Cunnamulla branch had 80 member families, making it the largest branch in Australia.

Cunnamulla branch has always had a strong and loyal group of ICPA members with many of them serving on State and Federal Councils. On Federal level was Geoff Arthur, Helen Miller, Colleen McIntosh and Trish McKenzie. On State level was Diana Palmer, Helen Miller, Wendy Allen and Jo Clarke. These people are here with us today. Thank you, Helen, Colleen, Trish, Wendy and Jo.

In 1996 Cunnamulla branch members Wendy Allen and Julie Collis took on the huge challenge of compiling a book titled "ICPA Silver Jubilee" on the first 25 years of ICPA – a wonderful tribute to a worthy organization.

Cunnamulla has held two State Conferences....and this will be the third. In October1983 Bev Blanch was the very capable Convenor. This was the 12<sup>th</sup> Annual State Conference. It was attended by over 300 people- not bad for a small and remote town in Queensland. Twenty years later, in 2003 Colleen McIntosh was the enthusiastic and well organised Convenor for the 32nd State Conference.

Cunnamulla branch now has two Life Members. Helen Miller in 1996 and Colleen McIntosh in 2003. When we were asked to do the "Welcome to Cunnamulla", we both felt quite humbled and very honoured. For me personally, I came to Cunnamulla as a new bride from NSW. Both my children attended the local Catholic school and then onto boarding school. Colleen was a local having been born here and lived in the district for 50 years before retiring to St George. Colleen had also attended boarding school so was well aware of the issues associated with Living Away from Home. Their sons were educated by SODE from Charleville before attending boarding school for their senior education. Her grandson now attends boarding school. I attended my first ICPA meeting in the early 1980's when Bev Blanch was organising the State Conference. My children were only five and three. "No excuse!" said Bev. This set me on a wonderful direction to becoming a committed and passionate ICPA member. I have made some wonderful friends and we get together regularly. Many are here today. ICPA has challenged me and enriched my life. Helen and I are still members of Cunnamulla branch. I attended my first conference in Longreach - was an extremely nervous first time delegate – spent 30 minutes in the bathroom practicing "I second that motion". So, for all the first time delegates here today ... take heart. I thoroughly loved my ICPA life –I have met some wonderful people and made life-long friends. ICPA taught me SO much in many many ways. It has been the backbone for what I have done later on.

When I first started on Federal Council they were talking about 'floppy disc' with computers – had absolutely NO idea what they were or, for that matter, how to use a computer!!! Did you know the ICPA magazine Pedals originated forty years ago here in Cunnamulla? In 1981, Toni Ridge from Enngonia (near Bourke) and Bunny Powne from Bollon, sat down together in the park just near where we are today, to plan the first edition of Pedals.... Lots of cutting and pasting of articles on to paper! How times have changed !!! ...... and how we have grown with technology.

This year Cunnamulla is hosting the 50th State conference with most of the organisation and meetings done via teleconference! We are very proud that the Cunnamulla members have banded together and overcome the significant barriers of COVID-19; remoteness and isolation. Congratulations to Rhi Newsham, her committee and members.

Welcome everyone to Cunnamulla.

## Auditor's Report

### Isolated Children's Parents' Association - Queensland Inc. For the year ended 31 March 2020

### **Qualified Opinion**

I have audited the accompanying financial report, being a special purpose financial report, of Isolated Children's Parents' Association - Queensland Inc. (the association), which comprises the committee's report, the balance sheet as at 31 March 2020, the income and expenditure statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and the statement by members of the committee.
