

## Secretary's Report

---

**Madam President, Distinguished Guests, Fellow Councillors, Delegates, and Members, it is my pleasure to present the Secretary's report.**

2022, what a year it has been. Apart from all the challenges many of us experienced in our own lives, it has been a big year for ICPA-NSW too. However, certainly not as big as 2020 and 2021 with the Covid challenges. Just as I was thinking of winding up from ICPA-NSW, I found myself thinking about how I could help fill a vacancy on the Executive. A decision I don't regret, it is amazing what you can juggle. I thought, oh well, if I have bitten off more than I can chew, I will just have to chew harder!

Trying to fill the shoes of our super-efficient previous secretary Deb Castle, is just a glimmer of hope for me, however everyone does it differently, but I am very lucky to be able to carry on from where Deb left off. Thank you, Deb, for your amazing years of service as an extraordinary secretary, we miss you each and every day, and for being at the end of the phone for me. Annabel Strachan was acting for a few months, and I thank Annabel too for continuing to keep the secretary's work under control.

We have held lots of zoom state council meetings throughout the year. These were fortnightly to start with whilst we all got use to our jobs and tried to cover off on some of the issues. It worked extremely well to have our main deputation to the New South Wales parliamentarians and organisations in June, rather than October. The issues should not wait any longer than they have too. They need to be discussed in these corridors as soon as possible after Conference. The mini deputation is now effectively held in October. This year State Council have worked on several other documents to help with the promotion and advocacy of issues. Firstly, it was the formulation of a policy document. This is a go to document for State Council and proved very handy when we decided to put together a pre-election strategy for the upcoming New South Wales election.

A pre-election Strategy containing 23 recommendations from branch motions, from across all the portfolios was sent to all Ministers and Shadow Ministers who would be dealing with the issues as well as the Premier, Opposition leader, Treasurer and Shadow Treasurer. We do hope that we see some of these recommendations implemented as part of the election. State Council have been wanting to put together role descriptions for all the various roles on State Council for quite some time. It is great to see that during 2022 we ticked this one off. So, if you are interested in any of the roles on State Council, we have a document that will provide you with the information, as well as a timeframe of meetings and events for State Council. We are hoping you won't start your role blindfolded anymore.

The current State Council are working on a handbook for all State Councillors. We think this electronic document would be of great value to each new State Councillor. It will contain the numerous forms, role descriptions, and other useful information that you need to do your job on State Council.

I am looking forward to continuing in this role in 2023. A huge thank you to our fantastic, kind and considerate President, Tanya Mitchell, who really does know what it is like to be juggling balls each and every day. Thank you also to all the members of State Council. Thank you for your support and assistance.

Farewell to Deborah Nielsen and Amanda McClaren. All the best and thank you for all that you have done, we will miss you.

## Treasurer's Report

---

We helpfully heard yesterday that we are not here to count spider's legs but I'm the guy who is counting the spider's legs. We won't go any further than that.

**Madam President, distinguished guests, fellow members of ICPA, ladies and gentlemen. It is with great pleasure that I present the Treasurer's Report for the 2022 Financial Year.**

These audited financial statements, with accompanying auditor's report, have been prepared by Audit & Risk Solutions Pty Ltd.

### **Statement of Income and Expenditure:**

#### **Income:**

Total Income for the 2022 financial year was \$159,183. This is down slightly on last year by about 9%. This amount consists of:

- Grants \$68,249
- Telstra \$5,000
- NBN Co \$4,454
- Department of Education \$58,704

#### **Conference income \$51,281**

It should be noted that, while income from the state conference is recognised as income in the financial reports the net result to State Council is nil. This is because at the conclusion of a state conference the balance of the conference account (- \$1,000), which is now included under the umbrella of ICPA-NSW, is expensed to the convening branch. This means that of the \$51k received by State Council, for the 2022FY, State Council recognised an equivalent total conference expense of \$51k, so this has a net nil effect on the profit and loss.

#### **Memberships \$11,853**

At the end of the 2022FY, ICPA-NSW had 25 financial branches (not including Lone Members). Membership numbers for the 2022 year are included in the Membership Officer Report. The 2023 memberships are currently still coming in, with a large portion of the 2022 memberships not coming in until after the end of the 2022FY (Jan & Feb 2023). ICPA-NSW is aware that some members have faced difficulties when renewing online. As with any system change there are always teething issues. We understand the frustrations and thank all members for their patience as these issues are worked through. Despite these challenges we do encourage all members to renew online as the utilisation of technology is an important step in enhancing the efficiency of the organisation. No, it's not perfect. Yes, it will improve, please stick with it. It's also a timely reminder that branch AGM's need to be held in October or early November as this really helps with ensuring that all members are financial at the close of the financial year which is December. It also ensures that branch fees are set prior to the opening of the next membership year which is November of each year.

#### **Merchandise sales \$2,872**

Merchandise sales have doubled on last financial year which is to be expected as things have opened up again post COVID allowing for more opportunities to make merchandise sales. We thank David Shrimpton for his diligence in managing the merchandise.

**Other sales \$24,928**

This category in the financial statements includes all other income received by ICPA-NSW during the 2022 FY including:

- Interest \$366
- Sundry \$662

Being funds received from the closure of the West Wyalong Branch.

- Donations \$4,925

This donation amount includes all forms of donations including member donations, branch donations and conference donations.

**Advertising \$455**

This amount has dropped significantly compared to last year. This is due to a delay in the issuing of the 2022 advertising invoices. Our Memberships Officer, who is responsible for collating this information, was tied up with competing work priorities due to the flood events of 2022. I can report that all 2022 advertising invoices have now been issued and we expect an additional \$8,749.91 (net of GST) of advertising income to be reported in the 2023 financial year. Note, the 2023 advertising income will be uncharacteristically high for the 2023 year due to this additional amount being received on top of the actual 2023 advertising income to be invoice in November/December of 2023.

**Affiliation fees \$18,520**

This is the portion of memberships that relates to Federal ICPA and the relevant branches. What this means is that, although ICPA-NSW recognises these fees as income, we do not hold any of these funds as they are all expensed out to the relevant branches and Federal ICPA. Total affiliation fees paid out for the 2022FY was \$17,141. The deference between affiliation fees received and paid out (\$1,379) is due to a timing difference between when the fees are received & when they are paid out but we do not hold any of these fees.

**Expenditure:**

Total expenditure for the 2022 year was \$167,026. This is down on last year by 14%. Of note out of the expenditures are following:

**State councillor expenses \$59,751**

This represents the cost associated with councillors attending meetings such as deputation as well as the costs associated with attending state & federal conference. Whilst there has been a considerable increase, compared to last year, in these costs it is to be expected given the easing of COVID restrictions which has allowed for the resumption of face-to-face events. There are considerable costs associated with moving bodies around the country.

**State conference \$51,790**

This expense has been addressed previously in this report (see conference income).

**Newsletter \$14,770**

Top Wire costs have increased slightly this year by \$2,710. This is predominantly due to an increase in printing and publishing costs. All other costs associated with producing and distributing Top Wire have remained relatively stable.

**Subscriptions \$1,874**

Subscriptions to Zoom and Dropbox have continued this year. These are vital services that enable State Council, which is geographically diverse, to meet and function administratively. Additionally, a subscription to Survey Monkey was established in the 2022FY which has been a useful tool to enable

State Council to gather information and data from members across the State with respect to certain issues and events. The utilisation and integration of technology into our processes and systems is a vital part for our organisation to gain efficiencies in the way we operate.

### **Net Profit/Loss:**

The net result for the 2022FY is a loss of \$7,844.

### **Assets and Liabilities Statement:**

As at the 31st of December 2022 ICPA NSW has:

#### **Assets**

Total assets for the 2022 year \$212,962 This amount consist of:

- Cash and Cash equivalents \$205,685 Included in this amount is:
- Lone Members account \$16,098
- Unexpended Donations \$14,526

The Unexpended Donations Account received a deposit of \$4,985.04 which, as was outlined in last year's treasurers report, was the amount held in trust by the Lone Members for the closure of the Warrumbungle Branch.

#### **Plant and Equipment \$1,452 (after depreciation)**

There were no new items of equipment purchased during the 2022FY.

Accounts receivable \$500

Merchandise on hand \$5,325

#### **Liabilities**

Total liabilities for the 2022 year \$37,607 This amount consist of:

#### **Accounts and other payables \$32,898**

Included in the amount is:

- Lone Members Trust \$22,804
- Unexpended Donations \$9,494

Both these accounts have not been utilised this year. As such the balance remains the same.

Net GST payable \$4,709 which was the December BAS and has since been paid.

#### **Lone Members:**

In July 2022 the new Lone Members bank account was established under the ICPA-NSW umbrella. This was an important move, as from a technical standpoint Lone Members Branch does not exist as an independent entity like all the other branches do. In essence they are an extension of ICPA-NSW. Having the Lone Members bank account under the ICPA-NSW umbrella ensures that all Lone Member funds are accounted for correctly, including any GST obligations. The key impact this will have on the financial statements is that, from the 2023FY onwards, the Branch affiliation fee associated with Lone Members membership payments will no longer show as an expense in ICPA-NSW financial statements. This is due to the fact that, fundamentally, an entity cannot incur an expense on itself. The distribution of the branch affiliation portion of a Lone Members membership payment, to the Lone Members account, will simply be a transfer of funds between two ICPA-NSW owned bank accounts, net of GST. All income to the Lone Members will be recognised as income to ICPA-NSW, as it always

has. All expenses incurred by Lone Members to external parties will be recognised as expenditure to ICPA-NSW. The distribution of Lone Members Branch affiliation fees will be a transfer and no expense is recognised. I thank Irene Lund for her offers of support as needed and it is greatly appreciated.

**Sponsorship:**

ICPA-NSW acknowledges the continued and valued support of Telstra & NBN Co. We also acknowledge the generous donations made by families, branches and organisations, whether it be financial, in kind or time. Our organisation does not exist without your continued support and so we offer of deepest thanks for all that you do to ensure that we can continue to support you in the things that matter most to you, your families, and the communities within which you operate and live.

It is also worth noting and I take this opportunity to draw attention to some of the challenges that we face as a volunteer and community-based organisation. There are sustainability concerns in our sector. It is not a financial concern as we are financial. It is more around the way in which we do business and how we do our business. It is not an ICPA centric issue and this is not anything to do ICPA as if we have created this problem. It is something that all community based and volunteer organisations are facing across the country. Getting people involved, we all understand, is getting increasingly difficult and the environment in which we operate, the funding environment and landscape, is changing and becoming increasingly difficult. These challenges just mean that we have to be really mindful and thoughtful around how we do our business because, if we don't do it sustainably, if we don't look after the people who we have in our organisation then, very quickly, all the issues we have been dealing with and talking about and fighting for become a byproduct and we don't have a voice at the table. It's the voice at the table which is the important thing to remember because, at the end of the day, we may not be the biggest voice at the table and we may not even be the voice that makes the final decision, but having a voice at the table is the thing that is the real value to our members because we give ourselves a chance. So, it is a challenge. I don't think any of us would find it difficult when we think of the communities from which we have come, to know of an organisation, a community-based organisation, that, perhaps in the last twelve months has ceased to exist or in next twelve months, won't exist. It's a real challenge to our sector and so we do really have to think about how we maintain our organisation in a sustainable way going forward so that we can continue to fight for these things in the generations to come.

**Acknowledgments:**

I would like to pass on my sincerest thanks to those on State Council whom I have had the privilege of serving alongside. It has been but a few short months but your warmth, acceptance and support is greatly appreciated. This group of State Councillors, individually and collectively, are an incredibly hardworking and committed group of people. The sacrifices they and their families make are significant and I would like to take this opportunity acknowledge the diligent work each and every one of you do in your respective roles.

I would personally like to thank our President, Tanya Mitchell and Secretary, Libby McPhee for your patience and understanding when dealing with my many, many questions as I've tried to find my feet as Treasurer. To Kerrie Johnston our esteemed Top Wire editor. Thank you for your continued hard work and commitment to producing a quality magazine. To Judy Newton our Federal Membership Officer. Thank you for your diligence, attention to detail and long hours you commit to ensure memberships end up to the people and in the places they belong. I have greatly appreciated your support in helping me get my head around the membership process.

To Shennah Joiner our immediate past Treasurer. You are an incredibly capable person. You did an outstanding job as Treasure and set a high bar for all those who would come after you. Your detailed and meticulous record keeping has been a life saver and given me great confidence. I have deeply valued having you on speed dial for those times I have got stuck.

To the many Branch Treasurers. Though I haven't dealt with you all personally, thank you for the vital role you play within each of your branches. The role of treasurer is often a difficult one to fill in any organisation, so your continued commitment and hard work is greatly appreciated.

I hereby request that this report and the audited financial statements be accepted. I also recommend that the state component of a branch family membership remain at \$18.00 for the 2023 membership year.

## Notes to the Financial Statements For the year ended 31 December 2022

### Note 1: Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of New South Wales. The committee has determined that the association is not a reporting entity. The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

#### (a) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### (b) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

#### (c) Goods and Services Tax (GST)

The ICPA is registered for GST.

## NSW Membership Officer Report

---

**Madam President, distinguished guests, members of ICPA, ladies and gentlemen. It is with great pleasure that I present the NSW Membership Officer's Report.**

- At the end of 2022 ICPA-NSW had 538 financial members. This is a significant drop in numbers because at the end of 2021, we had 830 financial members.
- This drop in membership numbers is partly due to new members not renewing since the covid pandemic. We had 104 new members in 2021.
- There have been some teething issues with the online membership renewals and we thank Federal Council for assisting us as the issues become known. We ask members to continue to persevere if they have not yet renewed.
