We have welcomed a number of responses to our correspondence and ICPA looks forward to working with the new Government and engaging and meeting with them.

On a personal note, may I thank members for the privilege once again of being your Federal President for this Council year. FEDERAL CONFERENCE REPORT



Mother nature did not consider the tenacity and grit that ICPA is known for when it tried to deter festivities by putting on its wildest weather during the week of Federal Conference. Despite flight delays, broken umbrellas, and plummeting temperatures, more than 160 delegates and guests joined together at the Carlton-Ritz for Federal Conference on Wednesday 3rd and Thursday 4th August.

Federal President Alana Moller opened conference by highlighting the suitability of this year's conference theme 'From the outback to the ocean – building member connections'. Alana conferred that this theme aptly describes what ICPA is all about, coming together for common aims. She also voiced that like many, she was overjoyed to be fully face-to-face for the first time since 2019.

While the Honourable Fiona Nash – Regional Education Commissioner, was not able to join us in person, as originally planned, she 'zoomed' in and set the tone of the conference with vigour and passion. She explained how her role provides her with the opportunity to identify key priorities in the regional education space and work towards achieving positive outcomes. She spoke optimistically about the new federal government's intentions surrounding regional, rural, and remote education and encouraged all ICPA members to not underestimate the reach and value that their advocacy has. She applauded ICPA for identifying and voicing the challenges in educating geographically isolated children but also having the solutions.

At the commencement of her president's address, Alana Moller mentioned that as she was scrolling through social media that morning, a quote from Theodore Roosevelt came up in her feed.
