FINANCIAL ASSISTANCE CONFERENCE REPORT – June 2021

As usual Financial Assistance continues to be a key issue for many of our members. The disparity continues to widen between (ever increasing) costs to complete the compulsory years of education (usually in a boarding school setting) and the fiscal support given by the State Government.

In 2021, boarding fees rose by 2%, tuition by 1% in contrast to no increase of LAFHAS. In the past ten years, the value of LAFHAS as a support towards tuition costs borne by families has eroded by a further 3% from 44.6% of costs to 41.2%. Another way of looking at the ever-widening gap is to compare the increase in tuition fees over the past ten years. Tuition has increased by \$4145 while LAFHAS tuition component has increased by \$1418 - a further \$2727 difference in out of pocket expenses for families.

As on previous occasions, ICPA Qld wrote to Minister Grace following conference to highlight the issue and then raised the matter at delegations. The three Financial Assistance related motions passed at Conference have been raised as issues with the relevant Department authorities with no response as of yet to two of the motions.

- Access to LAFHAS for student's whose secondary school does not provide the required subjects to meet their specific educational needs.
- Support package for families that employ home tutor where Distance Education is the only option.

In regards to the motion about LAFHAS funding not reducing if the CPI drops, Shadow Education Minister the Hon Dr Christian Rowan has been able to get a response back from the department. The Government has given the undertaking not to reduce the LAFHAS funding even though CPI has fallen by -1%

We have used available opportunities to increase the knowledge of other politicians around rural and remote students and the essential role boarding schools play in reaching desired educational, social and communal outcomes. ICPA will continue to lobby for rural and remote families and strive for a better LAFHAS deal.

While the past year has not seen the desired change in LAFHAS funding arrangements, it has not been for want of effort. Members may be rest assured this issue is still at the forefront of our advocacy and will continue to be so.
