

# PROFILES

#### TAMMIE IRONS, President ICPA Qld Inc

Tammie and her three children relocated to Toowoomba in 2018 after the sale of their property at Glenmorgan where they had been living for 14 years. Tammie's children were all schooled at the local small school and the two eldest experienced boarding for years before becoming day students.

Tammie grew up on her family cotton farm at Theodore in the Dawson Valley, attending a small school and boarding school before studying teaching at QUT in Brisbane. As a teacher she taught at several small schools in Central Queensland before moving to Glenmorgan with her family. A close neighbour, and passionate branch member of Westmar/Inglestone ICPA, took her to her first branch meeting and the rest is history! Tammie attended her first conference in Charters Towers in 2010 and caught the bug. She took on the role of Treasurer/Registration Officer for the Goondiwindi State Conference in 2012 and stepped onto State Council that same year. Tammie also acted in this role at the 2013 Toowoomba Conference, the 2014 Federal Brisbane Conference and the 2017 St George Conference. It was through this close involvement with both State Council and convening committees that Tammie has been able to see the magnitude of volunteer hours that go into making ICPA the valued organisation that it is today.

Tammie's time on Council has seen her lead the Early Childhood, Schools and Teacher Education portfolios. During this time, it has been her passion to ensure that the attraction and retention of quality teachers in rural and remote areas is a focus for the Department of Education. Tammie was heavily involved in the early creation of the Remote Kindergarten Pilot – now known as State Delivered Kindergarten – and enjoys sharing her love of teaching rural with preservice teachers at every opportunity.

Tammie was elected State Vice-President in 2015 and held that position for almost three years before becoming President at the 2018 Winton Conference. Ensuring that ICPA remains current and maintains its grass roots is core to Tammie's agenda. She enjoys hearing from members at all levels and encourages them to stand up and bring their issue forward as the best advocates for their children.

#### ALANA MOLLER, President ICPA Australia

In her second year as Federal President Alana Moller is a member of the Clermont Branch in Central Queensland. With her husband Scott, they own and manage a cattle station 'Star of Hope', west of Clermont. They have three daughters – two at boarding school and one in grade 3 via distance education. She has been home tutor for all three girls completing primary school via distance education and also trained as a high school teacher at Central Queensland University.

#### PATRICIA MITCHELL OAM, Patron ICPA Qld Inc

Mrs Patricia Mitchell is Patron and Life Member of ICPA-Qld Inc. She was instrumental in forming the Augathella ICPA Branch in 1973, was inaugural Secretary of Charleville School of the Air P&C ICPA Branch when it formed in 1976 and is a Life Member of Cloncurry Branch ICPA.

In 1977, Trish was elected to Queensland Council ICPA and was Queensland President from 1982 till 1986. From 1982 –1985 she was a Federal ICPA councillor and Federal President from 1985- 1988.

As President of Queensland ICPA she was a member of the Ministerial Advisory Committee on Distance Education in Queensland which recommended the formation of a School of Distance Education from the existing four Correspondence Schools and five Schools of the Air. She was then on a number of committees that implemented the recommendations of the Advisory Committee and planned new Schools of Distance Education.

During this time, she was also Commissioner on the Commonwealth Schools Commission and member of the Catholic Education Commission Committee for the Education of Country Children, member of the Home Schooling State Review Committee and numerous other State and Federal committees.

As well as her ongoing commitment to education in rural and regional Australia Trish has been very involved with the arts. She is a Vice Patron and a former President of Regional Arts Australia as well as being a Life Member and former President of Queensland Arts Council (now Artslink Queensland). She helped establish Arts House in Canberra and Chaired the Regional Arts Fund Panel in Queensland.

Because of her experience in these fields Trish was appointed to the Council of the Australian War Memorial from 1997 – 2004.

Patricia was awarded a Medal of the Order of Australia (OAM) on Australia Day 1996 for service to rural education and the arts.

As many of you will know I love quotes, and this one from Helen Keller has resonated with me repeatedly over a year which has seen ICPA working together across our state and indeed across the country in ways which we are not traditionally used to. The last 6 months have seen the power of ICPA come to the forefront and achieve so much for our boarding school families in particular – mainstream media refer to us as a 'peak' body and our voice has been more highly sought after than ever before. What an achievement for ICPA and I personally want to acknowledge and thank Federal President Alana, and State Presidents Claire, Sarah, Jill, Kate and Sally for their support and the information and knowledge sharing which has occurred between us all during these really tough times. The opportunity to lean on each other and lend an ear when the frustration became overwhelming was greatly valued and has certainly strengthened the relationships shared across our organisation.

In a typical year State Council would be attending a delegation in Brisbane at this time, putting forward motions from our branches and discussing how we can work together to achieve equity in education for our rural and remote families. 2020 has proven to be anything but typical and here we are – hosting our first ever virtual conference, coming to your live in your offices, kitchens, small schools and anywhere else we can zoom into! We are certainly blessed that communication has come as far as it has to allow us even the opportunity to host our conference in this way, and I thank you all for making the time to join us over the next couple of days to ensure that the strength of our lobby can continue for our kids. I would like to take this opportunity to mention Federal President Alana and thank her and her council for the support given to us in preparation for our conference. Having Federal as the 'guinea pigs' in regard to hosting a virtual conference has certainly given Queensland State Council the opportunity to learn from them and utilise some of their resources and we thank you all for your generosity.

Last year's Conference in Charters Towers was a huge success for ICPA Qld and we headed to Brisbane soon after for the first of our parliamentary and departmental delegations, joined by our newest councillors, Sonia and Kasie, and our new Treasurer, Amanda. Everyone embraced their new roles and relished their experience of the wheels of change firsthand.

Our midyear meeting took place in the very small community of Glenmorgan, the home of both Wendy and formerly myself, 3 hours west of Toowoomba on the Darling Downs. With a population of approximately 150 in the surrounding area, we were very capably hosted by the Westmar-Inglestone branch at the heritage-listed Myall Park Botanic Garden. State Council looks forward to these meetings every year as they give us the opportunity to meet some of our branch members in their own backyard, as well as valuable time together as a Council to go over motion progress and plans for the new year. We were delighted to receive a visit from Mrs Megan McNichol OAM who is a member of the nearby Western Downs branch, as well as a past ICPA Federal President. State Council always enjoy spending time with older members who can regale us with stories from the past with just as much passion for rural and remote education as ever before.

Kelly and I joined Federal and State Presidents and representatives in Melbourne in February this year for our annual Joint Council meeting. This is such a valuable gathering for all involved – we find it such an opportunity to share information and ideas with each other and forge relationships which in turn make it easier to pick up the phone and ask for advice or assistance when needed. Thank you to Federal Council for facilitating this meeting once again this year.

After another gruelling Christmas break dealing with ongoing drought, State Council made the decision to write a heartfelt letter to our Boarding Schools to highlight the impact of the drought conditions on our students physical and mental wellbeing going into the new school year. We felt it was important that this letter was shared with teachers within the day school as often they are unaware of what the life of a boarder looks like over the holidays. We were heartened by the response to our letter with many schools passing it around to all their staff, as well as sending us messages of support. Our letter was also picked up by the media, and we were grateful to be given the opportunity to speak to media at a state level about the realities of drought for our families.

Unfortunately, the second of State Council's delegations to Brisbane in March this year fell at the beginning of the Covid 19 lockdown. Meetings were rescheduled or cancelled, moved to teleconference or video conferencing platforms and our Secretary Kelly was kept incredibly busy attempting to keep tabs on everybody's whereabouts from afar! Qld Council had spent a lot of time creating our new look Portfolio Statement to present to Members of Parliament and it was certainly disappointing to have that face to face opportunity slip away. Although things had to be handled differently, it was a proud moment to witness our State Councillors lead the way in teleconference protocol as many MP's had little experience meeting in such a style!

Whilst Covid 19 has certainly had an impact on the way ICPA Qld has lobbied during the past 6 months, it has also served to highlight the day to day life of rural and remote families and the difficulties they face and overcome regularly. Our city cousins have had a slight taste of the trials of "teaching" their own children whilst trying to run a business or work from home, they've had to deal with internet and communication dramas and they've had to face a shortage of desired grocery items when shopping! Queensland State Council was able to share some highly successful "Tips for Home Schooling" across our social media platforms – tips from the experts! Many of our members very kindly sent in some great tips which we were able to share and we all learned something new. We were also fortunate to have the Department of Education facilitate daily teleconference updates which allowed us to keep up to date with the impact of the virus on schools and ask specific questions about our rural and remote students.

Perhaps the biggest part of our ICPA Qld year has been the impact of the virus on our boarding schools and families. Across the country we saw our boarding schools facing stringent restrictions which affected their capacity to offer boarding to our students. The Queensland government's interpretation of the AHPPC (Australian Health Protection Principal Committee) guidelines meant that it was incredibly difficult for boarding schools to operate and many students across the state had no choice but to stay at home for Term 2 or return as day students at their families own cost. With no information specific to boarding families readily available regarding returning to boarding in Term 3, State Council made the decision to start our #bringourboardersback campaign. We could not have foreseen the success of this campaign, with support flowing not only from our members, but also from other stakeholders, State and Federal politicians, the media and of course our ICPA counterparts at Federal and State level. One thing we have learned through our work this year has been that people need to see the human side of any argument for it to make sense and get real action. Being able to hear from our students directly about the impact of Covid 19 on their emotional and social wellbeing really hit home for many and I feel this was a huge part of the success of our campaign. We also held our first virtual 'rally' which allowed us to gather our members, along with other states, stakeholders and politicians, and come together to highlight the inequities our children and families were facing with no decision regarding boarding in Term 3 being made. There was certainly great relief at the easing of restrictions for boarding schools before those holidays, only to have boarding school issues rear their head once again for school holidays last term. Once again ICPA stepped up across the borders and fought long and hard to finally see the outcome allowing all boarding students to return home to their families for the holiday period and return without quarantining. It has been an incredibly tough 6 months for all and we are so proud of the ICPA community as a whole and incredibly grateful to those who stood up with us and made sure that our voices, however small, were heard loud and clear. As all the states dealt with similar issues, and with ICPA members boarding in different states, we were able to lean on each other and work together to ensure that every member, and even non-members, were being represented in the best way we could. I cannot describe the feeling each time we would hear news of further exemptions which would allow our families to be together again – feelings I am sure many of you on here felt – relief, warmth, victory and overwhelming exhaustion!

I would like to personally offer my thanks to Mr Tony Cook, the Director-General of Education Queensland, who took the time to listen, forward emails on our behalf, make phone calls on our behalf and personally call me, even on weekends, to support our fight for our boarders. Along with Tony, there are so many other people who offered support, advice and strength both in and across the states – too many to thank for fear I forget to mention someone! Please know that your efforts are always appreciated by Qld Council and our members at every level.

State Council headed to Emerald for a face-to-face meeting in September, with it offering a central location for all of our Councillors to attend. The weekend enabled us to plan for this conference, contribute to reports as well as providing a valuable opportunity to connect in a year where so many events have had to be rescheduled. Some of our Councillors zoomed in for a session, such is the beauty of technology, and lunchtimes provided an opportunity for many of us to contribute to the local economy and our wardrobe!

ICPA Qld are certainly fortunate to have such a great relationship with the Department, particularly through the Rural and Remote branch led by Regan Neumann and his trusty sidekick, Kym Turner. The team are always available to us for advice and information throughout the year, so I encourage members not to wait for conference if you have an issue. Please contact State Council so that we can work together for solutions when they are most needed.

Throughout the year, ICPA Qld are incredibly fortunate to have the support of so many people on the sidelines. Our amazing Patron, Mrs Trish Mitchell, who is a constant source of support and advice and such a regal role model. Nat Kenny, our News and Views editor, who will step down this year after having done such a terrific job of reinvigorating our magazine, along with her team of proofreaders. I have every confidence that our new editorial team will continue Nat's legacy. Lynelle Urguhart, our Webmaster, who has spent many years tirelessly at our beck and call dealing with the updating of our website information. Although Lynelle is stepping away from the role, and even as we introduce the new role of WebTech Officer, I know that Lynelle will always be on hand for any advice of assistance she is able to offer. Jeff Little, our IT advisor, who is always available for technical advice and support, and ensures that Telstra and the nbn are kept honest! Margie Greenway, who has been a representative of ICPA for our Hospital Schools for many years and steps away later this year. When I stood up for this position, I was in a vastly different personal position and relocating to Toowoomba with my children and starting to teach again full time had not been on my agenda! In saying that, it has been such a rewarding position to hold for so many reasons. ### SECRETARY'S REPORT

State President Ms Tammie Irons, Patron Mrs Patricia Mitchell, Federal President Mrs Alana Moller, distinguished guests, fellow Councillors and Qld Branch members, I present the Secretary's Report for the 2019/2020 year.

Conference saw many of us unprepared for the cool weather that Charters Towers had in store for us. We certainly infused the local economy with funds as we tried to source jumpers and blankets! While the weather was cold, the welcome was warm to the three new faces on State Council: Amanda Clark, Belyando Mt Coolon Branch, Sonia Spurdle, Charters Towers Branch and Kasie Scott, Clermont Branch. All three ladies hit the ground running and have been a fabulous asset to Council.

Following on from Conference, Tammie and I headed to Adelaide for the 2019 Federal Conference where, once again, members heartily debated the motions that were presented. A break over the summer brought us to March 2020, with State Councillors heading to Brisbane for delegations and to present to politicians our Position Statement. I am pleased to be presenting the Treasurer's report and audited financial statements for the 2019 - 2020 financial year.

### **Finances**

Auditing of ICPA Qld Inc financials has been conducted by Ringrose Button Chartered Accountants and

are attached to the AGM report. ICPA Qld Inc has run at a cash profit this year of \$40,847.55 and remains in a very stable position with \$100,538.14 invested in a term deposit.

Total funds available as at 31<sup>st</sup> March 2020 were \$218,303.23. The Profit and Loss Statement outlines a snapshot of the income and expenditure for the 2020 financial year.

A total income of \$247,972.09 was received - donations substantial donation from the Charters Towers convening

being the major income at \$145,345.43, with a substantial donation from the Charters Towers convening committee from the 2019 State Conference of \$61,651.93 and \$9,650.00 from ICPA branches. Thank you

to the Charters Towers convening committee and the following ICPA branches for assisting State Council with donations – Aramac Muttaburra, Arcadia Valley, Clermont, Julia Creek, Mt Isa BOTA, Tambo and Winton.

Other major donations were received from Tim Fairfax Family Foundation -\$60,000 and Drought Angels - \$15,000. Sincere thanks to all organisations and branches who have supported ICPA Qld this year. Other major income included fundraising with Art Union ticket sales at \$17,730.00 and Bush Christmas ticket sales at \$10,993.80. Branch membership state affiliation fees of \$24,922.72 were received. The remaining income received came from Friends of ICPA Qld and News

The large contribution to ICPA Qld's income each year is Fundraising. As previously mentioned sales of the ICPA Art Union tickets, ticket sales at Bush Christmas and the sale of souvenirs contributes to Fundraising income throughout the year. Thank-you to all sponsors and supporters of the ICPA Art Union and Bush Christmas. The time and effort our Fundraising Officer, Michelle Freshwater, has put into fundraising this year has been very much appreciated. Thank-you.

Each year a significant amount of funds are required for ICPA Qld State Council to continue lobbying Government departments to achieve a better educational outcome for our members' children. This lobbying has costs associated to assist State Councillors to travel considerable distances from home to attend these meetings. Total expenses for the year came to \$207,124.54 with \$73,452.44 covering State Council expenses. State Council expenses include accommodation, flights, travel and other related expenses for councillors to attend delegations, state and federal conferences, mid-year meetings, along with other relevant meetings and conferences. Other major expenses included \$16,336.46 for News and Views publication & postage, \$9,288.36 for insurance and \$4,516.68 for fundraising expenses.

#### **Membership**

The 2019 membership year closed with a total of 1,218 members and at the close of the financial year, 31st March 2020, there was 942 members. Memberships for the 2019 year were down slightly in comparison to the previous year. As always, memberships continue to flow in throughout the year and online membership renewal has continued to have a great uptake this year. Online is the preferred method for paying membership and it is great to see those branches encouraging the use of online membership for renewals or new memberships. Thank-you to Louise Winten, Qld Membership Officer and Jane O'Brien, Federal Membership Officer for all the hard work and many hours you put into keeping all our memberships records in order. You have made my first year as Treasurer run smoothly. Our membership base is what makes ICPA a strong organisation, so we encourage all branches to continue to engage and advocate for new and existing members to become involved in any way possible to support ICPA.

Just a reminder to branch executives, that if submitting your memberships manually, it would be fantastic if you could have them submitted prior to the 1st March each year. This ensures your members remain on both the State and Federal mailing databases. If your branch has Branch Life members, both State and Federal fees for these members are the responsibility of the branch and must be paid each year. All members need to keep their postal and email addresses up to date and notify State Council when changes occur. This makes the delivery of information and publications to members much more effective.

Friends of ICPA Qld have continued to grow in the 2019 – 2020 financial year with 56 members from organisations across Queensland. As Friends of ICPA Qld, members received an invitation to the annual conference, editions of ICPA Qld News and Views and ICPA Australia Pedals and the Qld Compass email keeping them update with ICPA happenings.

#### **Risk Management**

As State Treasurer, I am also the Risk Management Officer, so a reminder to all branches to send in completed risk management forms at least two weeks prior to branch events. If your branch has questions related to activities and insurance do not hesitate to contact me. It is important, that as members, you are covered, along with those attending your events.

Branches have been busy hosting and undertaking events throughout 2019. Many branches including Aramac Muttaburra, Blackall, Bollon, Charleville, Cunnamulla, Dawson Valley, Mt Isa BOTA, Nebo, Southern Downs, St George, Thargomindah and Yaraka Isisford have held catering activities at campdrafts, fundraising events, car rallies, races, Cobb & Co festival, bull sales, ladies' days, minischools and gun club shoots. ## FEDERAL COUNCIL REPORT

ICPA Queensland President, distinguished guests, Federal Life Members, Qld State Life members, fellow ICPA members and friends it is with great pleasure that I present the Queensland State Conference Federal Update to you under extraordinary circumstances, alas not in person, but nonetheless encouraged by all of you listening today.

I don't believe when the Conference theme of "Vision and Growth" was chosen that anyone could have envisioned where we and indeed the world, would be today. However it is a testament to the resilience and tenacity of all of you listening and ICPA as a whole that through these unprecedented times we have withstood challenges and continued to maintain and indeed grow in our solidarity and commitment ensuring the education of geographically isolated children remains at the forefront of our minds. My heartfelt congratulations and compliments to Queensland State Council for your efforts in bringing Queensland members together in this format.

Culminating in our first online Federal Conference in August the year that was has certainly thrown up more than its fair share of challenges and trepidations, yet still I can speak with you today to let you know of the achievements and efforts of Federal Council.

We were incredibly disappointed to not be able to come together physically for our Federal Conference this year. Indeed Federal Council were spread across Australia, unable to meet together due to border restrictions and COVID-19 outbreaks at the time of our Conference. However in the online format, Federal Council aspired to still provide a platform for our valued members to put forward their stories and points of view to assist us in formulating our policy and have the opportunity to ensure all of our members know they are supported. We are a member-based organisation, and it is our members who provide us with the inspiration and motivation to continue our work regardless of circumstances. For those listening who may not have attended our Federal Conference in August, despite a myriad of challenges to overcome, which were largely out of our control, including a solar flare which caused the Sky Muster network to fail an hour before the Conference was due to begin. This year's Conference was well attended by ICPA branch delegates and guests from all over Australia including Western Australia, Tasmania, Queensland, South Australia, Northern Territory, Australian Capital Territory and New South Wales. All agenda motions were presented, with healthy debate and discussion and how grateful we were for the support, understanding, patience and positivity of all of those involved. I would be remiss however to not particularly mention our gratitude to Richard and Tom from ABSA whose assistance was invaluable as I know it has been for Queensland State Council for this Conference.

It is an honour and privilege to have been elected again as Federal President at our Conference in August and to have the opportunity to work with all of the amazing individuals from all over our great nation on Federal Council for another year. In 2020, we have been thrilled to welcome two further Queensland faces to our team, being Nikki Mahony from Theodore and no stranger to Queenslanders, former Queensland State president Kim Hughes. We await with great anticipation when we can once again come together in person, as we have not been able to do so since October last year.

Federal Council is acutely aware that the past twelve months have been challenging for many of our members and is committed to supporting and advocating for all in our community suffering challenges and hardships. Of course the COVID-19 pandemic has been at the forefront of our minds and ICPA Federal Councillors have been working through issues that have arisen during COVID-19 and have been fortunate to have been able to assist members with some of their concerns and issues. It was heartening, to say the least, that out of the crisis have come some improvements in the area of communications, as well as a recognition of the unique needs of geographically isolated children when it comes to the Assistance for Isolated Children Allowance. Unfortunately, though the pandemic has also highlighted and in many instances magnified some of the inequities associated with educating children from geographically isolated contexts at all times, not just during a pandemic and these impacts were felt across all levels of education. All of the obstacles that have arisen for our families and their children have served to reiterate that geographically isolated students are a unique disadvantage group who need specialised and targeted assistance and support to access and attain equitable educational opportunities and outcomes.

At our Federal Conference I commented on how the COVID-19 pandemic is so fluid; it is difficult to predict what is ahead and indeed since then there have been ongoing issues, one of which was of course the issue of interstate boarding school students which we have been working on alongside Queensland State Council and other state councils across Australia. We were very pleased that the end of term three saw some short term resolutions to this issue however the collaborative effort between State and Federal councils to find solutions for interstate boarders continues to pursue a nationally consistent and long-term approach to this issue to provide students and their families with certainty and reassurance.

Now to update you on other activities of Federal Council, apart from the ongoing COVID-19 situation.

As well as actioning motions from this year's Conference, which saw a number of new topics to be addressed federally, we have continued to also advocate for all policy areas via numerous meetings, webinars and other forums and maintaining every effort to ensure our members' concerns and priorities are heard. Submissions are the favoured method for the government to gain comment and information on topics across many areas which we advocate for and Federal Council feels it is essential to be involved in these submissions and consultations wherever possible as we are able to make comment on our advocacy, from longstanding issues to current prevalent concerns.

ICPA Australia welcomed the appointment of a Minister for Decentralisation and Regional Education, the Honourable Andrew Gee MP in early 2020. An acknowledgement by government that regional education requires a dedicated ministry to focus on the unique circumstances of geographically isolated families and students and over the past months, we have had the opportunity to work closely with his office regularly on a range of topics. We look forward to our continued relationship with the Minister and his staff.

One of the topics which we are keen to keep in the forefront is the ongoing focus of our attention on Early Childhood Education and Care and especially In Home Care and the role it plays for geographically isolated families and along with this, the supervision of distance education lessons. The inception of the Relief Childcare Package during the COVID-19 pandemic did nothing to relieve the challenges faced by remote families using In Home Care, highlighting that a blanket approach to educational and child care issues, when applied to rural and remote situations is often inappropriate, unworkable, inaccessible and ultimately inequitable. We will continue to raise that with the recognition by government that regional education requires a dedicated ministry, so to do specialised models and programs need to be established for rural and remote families to address the unique disadvantages and needs associated with caring for and educating children in geographically isolated locations.

This is also the case with the Assistance for Isolated Children Scheme or AIC. The original intent of AIC was to assist with alleviating costs associated with educating geographically isolated students, and we have persisted in highlighting the need for AIC to be retained and maintained for these students and their families and called for assurance that the scheme is meeting the needs of geographically isolated families.

In the area of tertiary education, Federal Council were elated to receive news in June that a 'Tertiary Access Payment' would be made available for rural and remote students to access a tertiary education. Some changes have been made to how the Payment was originally intended to be administered and we are continuing to monitor and raise the perspective of our members as this is being developed.

Federal Council has also maintained our commitment to supporting and advocating for all in our community suffering challenges and hardships, continuing to pursue the introduction of a Rural Hardship Education Fund to ensure geographically isolated children can continue their education unhindered at any time of rural hardship. It was encouraging to see our call for a Rural Hardship Education Fund put as a motion in the Senate by Senator Pauline Hanson in October and given unanimous support in the Senate. Federal Council continued to build momentum off this, with contact made with Federal Ministers, Members of Parliament and Senators and media coverage.

ICPA Australia continues to maintain relationships with other individuals and groups to enhance our advocacy. We have continued to connect with organisations such as the National Farmers Federation and other agricultural groups, Dolly's Dream, the Australian Boarding Schools Association (ABSA), the Outback Alliance, the Better Internet for Rural, Regional and Remote Australia team (BIRRR), Telstra, the Australian Curriculum Assessment & Reporting Authority (ACARA), the National Rural Health Alliance (NRHA), the National Broadband Network (NBN) and the Primary Industries Education Foundation Australia (PIEFA) to name a few and most recently we were pleased to have the opportunity to become part of the Telecommunications Industry Ombudsman Consumer Panel. We have also been able to participate in a variety of consultations, webinars, meeting and roundtable discussions regarding postschool career advice, school funding and the National Evidence Institute amongst other activities. It is especially useful to participate in a range of activities and work with other organisations to be able to raise our specific priorities and keep our voice heard.

We also feel so fortunate to have recently been approached by the McDonald Family and the Four Seasons Company, owned by the Olsson family with the generous gesture of ICPA being a beneficiary of a percentage of the sales from ZM nutrition blocks for cattle released in honour of beef industry leader, the late Zanda McDonald. It is with a great sense of pride and humility that we are a part of this initiative. Zanda's family are longstanding supporters and volunteers for ICPA and geographically isolated children. On behalf of Federal Council, I would like to again express our humblest gratitude and appreciation to the McDonald and Olsson families.

Federal Council is looking forward to being involved with a study being undertaken by the University of Canberra's Rural Education and Communities Research Group to identify issues and garner data across rural and remote education. This project will give ICPA the opportunity to draw on the information gathered to assist with our advocacy across all areas of rural and remote education. We thank Natalie Downes and Phil Roberts from the University of Canberra for giving the opportunity to ICPA to collaborate and be involved with this project.

Federal Council is delighted to work closely with State Councils across many areas. A wise man once said "Determined people working together can do anything" and although our last face to face Joint Councils meeting was in February, COVID-19 has given rise to opportunities and indeed the need for us to work closely and collaboratively on a number of issues which have arisen. Along with our advocacy, all Councils have been focussed on working together this year on the development of a new look ICPA website which will hopefully meet members' and ICPA's needs better. The development of this website is well underway, and we look forward to releasing a dynamic new online experience for our members and supporters.

I really cannot thank all State Councils and also my fellow federal councillors enough for the amazing efforts they all continue to maintain across Australia and I can assure Queensland members that Federal Council and your State Council are most certainly here to support you in whatever way you need and will continue to do so through whatever should come our way. May I take this opportunity to show my gratitude and admiration to Tammie for her impeccable leadership as she stands down from the role of Queensland President at the end of Conference. Tammie it has been a pleasure to work with you this past 14 months and I wish you much happiness and prosperity as you move on.

As I draw to a close I wish to let all members know that ICPA Australia is looking forward to celebrating, hopefully with many of you, 50 years of ICPA in Longreach in 2021. Between now and then though, let's not forget that whether face to face, virtual or anything in between we are all here to support each other, and this is no more obvious than when we come together at Conference, because as I have said before, being isolated does not mean you are alone.

### **Retiring President**

As your Patron I am delighted to be asked to thank, on behalf of all our members of ICPA Qld, our retiring President, Tammie Irons, for the huge contribution she has made to the work of our Association at all levels.

This she has done despite often difficult personal circumstances as well as political and public ones. Who could have predicted the chaos that 2020 was to bring to us all but has been felt so strongly by families with children to educate?

Tammie's role as a practising teacher has been invaluable when dealing with issues such as teacher training and deployment, curriculum development and other educational issues as well as parental involvement at all levels. This all began when she joined the Westmar–Inglestone Branch in 2005. Then the introduction of Prep into schools was a big issue as was some years later, the making of Year 7 part of secondary schooling. Her passion for education and the needs of families in rural and remote areas meant that she worked tirelessly to ensure that all teachers who worked in those areas were well equipped for the role.

When Tammie attended her first state conference, at Charters Towers in 2010, as a delegate she found it such an inspirational experience that she determined to become involved beyond branch level. Having been the Branch Publicity Officer for many years, in 2012 Tammie stood for election and joined Queensland State Council. Among other activities she became involved with convening Committees for the Goondiwindi and Toowoomba State Conferences and the Brisbane Federal Conference.

## **Auditor's Report**

### Isolated Children's Parents' Association - Queensland Inc. For the year ended 31 March 2020

#### **Qualified Opinion**

I have audited the accompanying financial report, being a special purpose financial report, of Isolated Children's Parents' Association - Queensland Inc. (the association), which comprises the committee's report, the balance sheet as at 31 March 2020, the income and expenditure statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and the statement by members of the committee.

In my opinion, except for the effects of the matters described in the Basis for Qualified Opinion paragraph, the accompanying financial report of the association for the year ended 31 March 2020 gives a true and fair view of the financial position of the association and of its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements, and, in all material respects, in accordance with the Associations Incorporation Act 1981.

#### Basis of Qualified Opinion

Our audit report is thus qualified n the completeness of income.

My responsibility under those standards are further described in the auditor's responsibilities for the audit of the financial report section of my report.
