Following Julia Creek State Conference, Delegations were held in early August 2023 in Brisbane. We were fortunate to be hosted by Brisbane Boys College and thank Headmaster, Mr Andre Casson and his wonderful staff for supporting ICPA in this way. Our every need was met.

Being the first Delegations post conference, there was much to be done and we met with the Department of Education, BSDE, DESBT, the Minister's Advisor, Dr Christian Rowan and other relevant organisations including QCT, QCAA, SPELD. Councillors were kept very busy representing the motions from Conference which became ICPA policies.
