We have also had Federal Council representatives at all state conferences these past few months and while I have had to miss several due to some health problems, it has been



heartening to finally have the opportunity for at least some of us to come together. It was a thrill to be a part of celebratory anniversary events held in New South Wales, South Australia, the Northern Territory and online with Western Australia. My personal highlight though, was to be in Bourke, the birthplace of ICPA, celebrating 50 years with the founding President, Mr Wally Mitchell. This opportunity was such a momentous and historic occasion that I felt so very privileged and humbled to be a part of.

Like raising children, it isn't necessarily going to be easy, however I can assure you that it is most certainly worthwhile.

So now as we make final plans for the 2022 Federal Conference, while I hope to see many of you there, may I take this opportunity to remind you all that no matter where you are, being geographically isolated does not mean you are alone.
