On-demand Transport, Department of Transport, announce ability to change existing flights to return students home

The Isolated Children's Parents Association of Western Australia (ICPA WA) welcomes news from Ondemand Transport, Department of Transport, that families will be able to change their pre-existing flights if students need to return home due to their educational institution or boarding facility closing.

"Families that live within the Defined Remote Area (DRA) of Western Australia, that are eligible to receive the Student Travel Subsidy Scheme Fares Allowance, are required to submit their travel arrangements at least one month in advance to qualify for a travel voucher. Consequently, many families have already made travel arrangements for the end of Term 1 on 9th April. Member families expressed concern to ICPA(WA) that they had received information that these vouchers had to be used on the specified date and travel on an alternative date would be borne by the individual." State President, Sally Brindal said.

ICPA (WA) have since contacted the Department of Education and Training, and the Department of Transport requesting cooperation and flexibility on this issue as the effects of COVID-19 are startling and moving at a very fast rate.

Ms Brindal is pleased to relay back to their members that On-demand Transport have contacted affected families and informed them that —

"From now until 30 April 2020, families will be able change their existing flights if students need to return home due to their educational institution or boarding facilities closing. The Department of Transport will cover the cost of changing flights (i.e. if there is a difference in flight costs), however discretionary expenses will still be borne by parents (i.e. extra baggage, seat allocation etc.). The amended booking must be in the same fare category as the existing booking".

These arrangements apply to CTM bookings, bookings made through regional travel agents and direct with airlines.
